## ••• 4. Skipping Quality Control Inspections

Pitfall: Receiving defective or off-spec goods.

#### **How to Avoid It:**

- Always perform pre-shipment inspections.

## ••• 5. Overlooking Intellectual Property (IP) Protection

**Pitfall:** Your design or product is copied and sold by someone else.

#### **How to Avoid It:**

- Register your trademark in China.
- Use NDAs and manufacturing agreements.
- Work only with trusted suppliers vetted by your sourcing agent.

## ••• 6. Misunderstanding Shipping and Incoterms

Pitfall: Unexpected costs or delivery issues due to confusion over who handles what.

#### **How to Avoid It:**

- Learn the basics of Incoterms (EXW, FOB, CIF, DDP).
- Confirm who handles customs clearance and last-mile delivery.
- Consult with your freight partner or sourcing agent.

## ••• 7. Ignoring Cultural and Communication Barriers

Pitfall: Misunderstandings that cause delays or errors.

#### **How to Avoid It:**

- Communicate in clear, simple English.
- Confirm understanding in writing.
- Use bilingual sourcing professionals or agents to bridge the gap.
